The Rules and Regulations of the "Fuel Your Future" Car Raffle are set forth below. **By purchasing a raffle ticket, the purchaser agrees to be bound by these rules and regulations.** Interpretation and application of these rules and regulations by Ken Ganley Companies and Adoption Network Cleveland's "Fuel Your Future" Raffle shall be final.

The Final Drawing for the "Fuel Your Future" Raffle will be held on September 23, 2023, during Adoption Network Cleveland's Silent Auction and Benefit (the "Event"). The drawing is open to event ticket holders and may be streamed live and/or recorded for internet-based social media. The winner must be able to produce a legal issued ID and valid driver's insurance.

II. TICKETS

The ticket entitles the holder to be entered into a drawing for the “Fuel Your Future” 2-Year Lease on a 2023 Subaru Outback.

There is no maximum on the number of tickets that will be sold. The chances of winning are based upon the actual number of tickets sold.

By purchasing a ticket, regardless of whether or not the purchaser is eligible for participation in the “Fuel your Future” drawing, the purchaser agrees to the terms provided herein and to be bound to same.

IV. ELIGIBILITY

In order to be eligible to purchase tickets for an entry to win the Fuel Your Future, 2-year Lease on a 2023 Subaru Outback from Ken Ganley Companies, **you must be an individual eighteen (18) years or older with a valid state-issued driver’s license.** If the name of more than one person is submitted on a ticket and the ticket is selected as a winning ticket, the first otherwise eligible person named on the ticket (from top to bottom, left to right) will be deemed the holder of record of that ticket and declared the winner. V. PRIZES

The drawing will be held on September 23, 2023, 9:30 PM ET and will result in the selection of the winner of the Adoption Network Cleveland "Fuel Your Future" prize.

Winner will be notified in-person, or by phone and/or email. If the winner did not provide a phone number or email, all effort will be made to send a certified letter will be sent to the billing address associated with the method of payment, if any, listed for the winning ticket.

BY PURCHASING A TICKET, THE PURCHASER HEREBY WAIVES THEIR RIGHT TO A JURY TRIAL AND AGREES TO BE BOUND TO THE DETERMINATION OF AN ARBITRATOR. Cleveland, Ohio 44113. The terms and conditions provided herein shall be interpreted through the application of Ohio law.
